

Definitions of Residency Classifications

Employer Pay SB53

A person who is on an approved third party contract who does not live in Ohio, the employer is located in Ohio and is covering educational expenses. Determined each semester based on an approved third party contact. Please contact thirdparty@owens.edu for more information.

F-1 International (International tuition rate)

This immigration classification is available only to full-time, enrolled students working toward a degree or certificate or specified course of study at a U.S. institution of higher education. The F-1 is valid for as long as the student remains in school and carries a full course of study. Students with F-1 visa status are not eligible for Ohio Residency Status Change for tuition purposes. International F-1 students pay the equivalent to the international tuition rate.

International F2 and M2 Visa Holders

People issued a F-2 and M-2 VISA (dependents of F-1 and M-1 VISA holders) can now enroll at the college level on a part time basis. Students may enroll in 1 - 11.99 credit hours.

International (Not F-1) (International tuition rate)

Non-U.S. citizens who are in the United States on a visa type other than F-1. International students pay the equivalent to the international tuition rate, some exceptions apply. [Click here](#) for additional information on studying in the United States.

Forever Buckeye (C-5) (In-State tuition rate)

A person that is currently living in Ohio and has previously graduated from an Ohio high school.

Mature Citizens Status (In-State tuition rate)

The Mature Citizens Program is designed for Ohio residents 60 years of age or older who want to take courses at the College.

- Only Instructional fees are waived for mature citizens taking courses on a non-degree (audit) and space available basis. **Tuition and other required fees still apply.**
- Mature citizens are responsible for books and other expenses attached to the course.
- All academic policies and procedures apply to mature citizens.
- To initially set up this status the student must contact Oserve to discuss required steps.
- If **registering for classes online** once the Mature Citizen Status has been set up, students must send an email from their Owens email account, each semester to oserve@owens.edu, indicating that they would like to take the courses on an "Audit" basis in order to receive the discounted rate.
- Mature citizens desiring course credit must pay required tuition and fees **and must contact Oserve to reverse their mature citizenship status with the college so fees can be assessed correctly.**

Non-Resident (Out-of-State tuition rate)

Students who are not considered residents of the State of Ohio are charged nonresident (out-of-state) tuition rates by the college in accordance with Ohio Department of Higher Education Residency Rule 333-1-10.

Part-Time Resident (E-1) (In-State tuition rate)

A person who has recently moved to Ohio, established permanent domicile in Ohio and is gainfully employed on a full-time or part-time, self-sustaining basis by an Ohio employer and who is pursuing part-time program of instruction.

College Credit Plus

Option A: High school students may enroll for college credit only, and the student is responsible for tuition, fees and books.

Option B: High school students may enroll for high school and college credit. Tuition, fees and book expenses will be paid for by the state and students' home school. Students will be responsible for all course expenses beyond text and workbooks.

Reciprocity - Indiana (In-state tuition rate)

Indiana residents enrolled in the John Deere or Caterpillar Dealer Service Technician programs.

Reciprocity - Monroe County, MI (In-state tuition rate)

Monroe County, MI residents enrolled in a qualifying program.

Resident (In-State tuition rate)

A person who has resided in Ohio twelve consecutive months, who is qualified as a resident to vote in Ohio and who may be subjected to tax liability or has met one of the Ohio residency criteria for this status.

Selective Service Not Confirmed (Out-of-State tuition rate)
